**U.P. Technical University, Lucknow
Ordinance for
Master of Pharmacy (M.Pharm.) Programme**

1- Admission:

1.1- Admission to the M.Pharm. First Semester will be made as per the rules prescribed by the Academic Council of the University.

1.2- Admission on migration of a candidate from any other University to the U.P. Technical University is not permitted.

2- Eligibility for Admission:

2.1- Admission through Entrance Examination

(i) Candidate who have passed B.Pharm. examination from AICTE approved institutions with 60% marks.

(ii)- Candidates with 60% marks and who are GATE qualified will be given preference over Candidates who are not GATE qualified in affiliated institutions /Colleges of the University where M.Pharm courses are approved by the AICTE and the University .

(iii)- The Academic Council shall have the power to amend the eligibility criteria laid down in 2.1 (i) and 2.1(ii) within the frame work of guidelines of the All India Council of Technical Education.


2.2- Direct admissions on Vacant / Management seats at Institutions / Colleges level

The eligibility criteria for direct admissions on seats remaining vacant in the first year after entrance examination counseling as well as for Management seats shall be notified by the University from time to time.

3- Duration of Courses:

3.1- Total duration of the M.Pharm course shall be two years , each year comprising of two semesters. Each semester shall have teaching for 90 working days or as prescribed by the AICTE from time to time.

3.2- The maximum period allowed to a candidate for completion of M.Pharm course shall be four years from the date of admission ,failing which he/she will not be allowed to continue for the award of his/ her M.Pharm. degree.



4- Cancellation of admission:

The admission of a student at any stage of study shall be cancelled if:-

- (i) He / She is unable to complete the course within four years from the date of admission .
- (ii) He / She is not found qualified as per AICTE norms / guidelines or the eligibility criteria fixed by the University.
- (iii) He /She is found involved in creating indiscipline in the Institution /College or in the University.

5- Attendance:

5.1- Every student is required to attend 100% classes. However, the student shall be allowed to appear in the End Semester Examination only when he /she has attended not less than 75% class of each theory and practical subjects in that semester.

5.2- A maximum relaxation of attendance upto 15 %to a candidate can be given by the Head of the Institution / College provided he /she has been absent with prior permission of the Head of the Institution /College or due to accident / serious illness duly certified by the Registered Medical Practitioner/ Civil Surgeon subject to satisfaction of the Head of the Institution / College.

5.3- No student will be allowed to appear in End Semester Examination if he /she does not satisfy the requirements of attendance as per clause 5.1 and 5.2.

5.4- Attendance for the dissertation work shall be verified by the Supervisor/Guide and candidate will be allowed to submit dissertation when he /she has worked for at least 36 weeks after the date of admission in third semester out of which 32 weeks must be in the College/ Institution.He /She may be allowed to work in any other Institution/College for 4 weeks to avail some specialized facility with the permission/Guide/Supervisor and the Head of the Institution/ College.He will have to submit certificate of satisfactory attendance during work in other institution from its Head / Director.

6-ChangeofCollege:

Change of college/Institution shall not be permitted.

7- Examination:

7.1- The performance of a student in 1st and 2nd semester shall be evaluated through continuous assessment and End Semester Examination. The continuous assessment shall be based on class tests, assignments, seminars, day to day practical experiments, quize, viva-voce and regularity. The End Semester Examination shall be conducted by means of written papers/ practicals, evaluation of synopsis and preparation viva-voce.

The distribution of sessional marks for theory subjects /practical shall be as follows:

(a)- Theory

Test 80%
Attendance 20%

(b)-Practical

Practical day to day 50%
Viva-Voce 30%
Attendance 20%

7.2- A student shall start dissertation work after getting registration in the third Semester but shall be allowed to submit the dissertation with due permission of the supervisor / guide atleast 36 weeks after getting registered in third semester provided he/she has cleared all the back papers of first and second semester.

7.3- The supervisor / guide of the student shall be faculty member of the College / Institution. The topic of dissertation and name of the supervisor /guide shall be duly approved by the concerned Head of the College /Institution.

7.4-Evaluation of dissertation :

Internal assessment marks will replace sessional marks with 30% weightage given to the supervisor. The remaining 70% will be given by the committee comprising of supervisor (convener), one External Expert, one Internal Expert and HOD as members. The average of marks given by each committee member excluding the conveners will be added with 70% weightage to 30% weighted marked given by Supervisor.

8- Declaration of Results;

A candidate shall be declared pass in a semester if he/ she obtains :

(i)- 50% marks in each theory paper/practical examinations (including sessionals) with a minimum of 40% marks in each End Semester theory paper and practical examination.

(ii)- 50% marks in dissertation examination

9- Promotion:

9.1- Candidate satisfying all the requirements under clauser 8 shall be promoted to next semester/shall be declared pass.

9.2- A candidate shall be eligible for provisional promotion with back paper(s) to ;

(i)-2nd semester provided he/ she fails to satisfy the requirements of clauser 8(i) not more than two theory papers/ Practicals in a semester examination.

(ii)-3rd semester(2nd year) provided he/she fails to satisfy the requirement of clause 8(i) in , not more than two theory papers /practicals each in first and second semester i.e not more than four theory papers / practicals at the end of second semester.

(iii)-Special/Supplementary Examination shall be held after First and Second Examinations for the candidate who have qualified for promotion with back paper(s).

(iv)- The marks awarded to candidate in back paper/ special examination shall replace the previous marks.



9.3-A candidate who fails to satisfy requirements of clauses 8 and / or 9.2(i) &(ii) shall be declared fail and will be required to repeat the semester as a regular or as Ex-student.

In case of a regular student, he / she will be given re admission in the semester and the remaining conditions will be same as for the fresh candidates. In case of ex-student, he / she shall be allowed to appear in the end semester examination after he / she fills in the examination form and deposits the examination fees.

However, his / her sessional mark will remain unaltered for declaration of result. A candidate declared promoted may also have an option to repeat the semester only as a regular student. The failed candidate opting for Ex-studentship shall be required to register in the Institute / College within 15 days after the declaration of result.

10- Declaration of Division:

Division shall be awarded only in the final semester examination on the basis of grand total of marks obtained in all the semester examinations of the course. The award of division shall be carried on the following basis;

(a)- Candidate obtaining 75% or more of the grand total..... **FIRST DIVISION with HONOURS.**

(b)- Candidate obtaining 60% or more but less than 75% of grand total..... **FIRST DIVISION.**

(c)- Candidate obtaining 50% or more but less than 60% of the grand total..... **SECOND DIVISION.**

11- Merit List:

A candidate who passes all the examination in one attempt shall be eligible for inclusion in the merit list and shall be eligible for award of medal /prize.

12- Grace Marks:


A candidate shall be entitled for the award of grace marks upto a maximum of five marks in any one of the theory papers / practicals to pass a semester examination. No grace marks shall be awarded in back paper / special examination. The grace marks shall not be added to the grand total for the purpose of awarding division or honours.

13- Scrutiny:

A candidate shall be entitled for the scrutiny of his / her examination result according to the regulation laid down by the University.

14- Unfair means:

Cases of unfair means shall be dealt as per the rules, if any, of the University and The U.P.Public Examination (Prevention of Unfair means) Act.
